- 3) Treasurer's Report: The Treasurer's report was filed for Audit.

Comments: There are some outstanding receivables. \$1,900 for Hydro in January and part of February seems high. This, and other questions, will be addressed at the next meeting.

4) Superintendent's Report: P. Stos is away at a golf course management conference. His report was reviewed and there were no questions. In terms of placing cameras, a recommendation was made to have one in the cart area. This will be referred to the Superintendent and the budget committee.

5) General Manager's Report: There will be a new league on Wednesdays at 5pm for Spark Golf, a 9-hole social golf league. www.spark.golf There will be 5 tee times for 20 golfers each week. Once the mixed league starts, these two groups will start on the front or back in rotation.

Huron Pines is only responsible for providing tee times. Spark League members will manage everything else. The price given to the group did not include carts. Rack rate is the full rate for green fees. They will pay up front, 48 hours in advance. \$34.25 plus tax for 9 holes and \$13 plus tax for carts. The General Manager will provide the Secretary with a copy of the Spark Golf contract.

Some requests for alternative formats for men's night have been received and are being considered, such as a scramble or "shamble". Ladies will continue as they are in terms of format. The GM is working with the Chair on a gas rebate, previously discussed. The filing will be for the last 4 years.
