- TYPICAL DETAILS SHOWN ON THE DRAWINGS SHALL GOVERN THE WORK. IF DETAILS ON OTHER DRAWINGS CONFLICT THE MOST STRINGENT SHALL GOVERN.
- CONTRACTOR ASSUMES ALL RESPONSIBILITY OF DESIGN, ERECTION AND REMOVAL OF TEMPORARY WORKS. CO-ORDINATE SUCH WORK WITH THE ENGINEER BEFORE PROCEEDING.
- PROVIDE TEMPORARY BRACING, SUPPORTS AND/OR OTHER INSTALLATIONS NECESSARY TO MAINTAIN PLUMBNESS, TRUE, ALIGNMENT AND STABILITY OF THE STRUCTURE AND ALL OF ITS PARTS THROUGHOUT ALL ERECTION STAGES.
- 7. IT IS THE ULTIMATE RESPONSIBILITY OF THE CONTRACTOR/OWNER TO ENSURE THAT ALL REQUIRED PERMITS AND APPROVALS ARE OBTAINED & POSTED PRIOR TO PROCFEDING WITH CONSTRUCTION, IT IS THE RESPONSIBILITY OF THE CONTRACTOR TO COVER THE FULL COST OF PERMITS (INCLUDING THE BUILDING PERMIT) AND FEES. THESE PERMITS/APPROVALS MAY INCLUDE (BUT ARE NOT NECESSARILY LIMITED TO):
- MUNICIPAL BUILDING DEPARTMENT PERMIT TO CONSTRUCT (MULTIPLE PERMITS MAY BE REQUIRED) I) ELECTRICAL SAFETY AUTHORITY (ESA) PERMIT II) MUNICIPAL BUILDING PERMIT

### TEMPORARY SERVICES DURING CONSTRUCTION

- 1. THE CONTRACTOR WILL HAVE ACCESS TO REGULAR EXTERIOR POWER RECEPTACLES DURING CONSTRUCTION. IF THE CONTRACTOR USAGE CAUSES BREAKER ISSUES, THEN A PORTABLE GENERATOR OR OTHER POWER SUPPLY WILL BE REQUIRED DURING CONSTRUCTION.
- 2. THE CONTRACTOR WILL HAVE ACCESS TO PUBLIC WASHROOM FACILITIES DURING CONSTRUCTION.

### LAYDOWN/SITE TRAILER/STORAGE AREA

- PROVIDE MIN. 2.4M HIGH CHAIN LINK OR WIRE MESH FENCE (WITH LOCKABLE GATE) AROUND ALL DUMPSTERS, SITE TRAILERS AND MATERIAL STORAGE AREAS. NO LOOSE MATERIALS SHALL BE LEFT ONSITE UNSECURED DUE TO POTENTIAL HIGH WINDS AND/OR THEFT.
- 2. ALL AREAS TO REMAIN CLEAN AND ORGANIZED THROUGHOUT THE CONSTRUCTION.

### WORK SITE PROTECTION AND CLEAN UP

- ENSURE THAT APPROPRIATE BARRIERS (PLYWOOD SHEATHING, TARPS, ETC.) ARE IN PLACE TO PROTECT BUILDING COMPONENTS/FINISHES FROM DAMAGE DURING CONSTRUCTION.
- ENSURE APPROPRIATE GUARDS ARE IN PLACE TO PREVENT CONSTRUCTION DEBRIS FROM FALLING AGAINST WINDOWS, DOORS AND EXTERIOR AIR CONDITIONING/AIR EXCHANGE UNITS.
- CONDUCT DAILY CLEANUP OF THE WORK SITE TO ENSURE THAT ALL CONSTRUCTION DEBRIS (INCLUDING DUST, CONCRETE, PAINT) IS MANAGED PROPERLY.
- 4. AT THE COMPLETION OF THE WORK, CLEAN ALL SURFACES OF THE BUILDING (INCLUDING WINDOWS, DOORS) THAT HAVE BEEN AFFECTED BY CONSTRUCTION, TO THE SATISFACTION OF THE CONSULTANT/OWNER.
- 5. AT THE COMPLETION OF THE WORK, ENSURE THAT THE PROPERTY (PARKING LOTS, GRASSED AREAS, OTHER LANDSCAPED AREAS, ETC.) ARE REPAIRED TO A PRE-CONSTRUCTION CONDITION.
- 6. ALL CLEANUP SHALL BE TO THE SATISFACTION OF THE CONSULTANT/OWNER.

### SCOPE OF WORK AND CONTRACTOR PRICING

- 1. THE SCOPE OF WORK GENERALLY CONSISTS OF THE REMOVAL OF THE 775m<sup>2</sup> METAL ROOF, STRAPPING AND UNDERLAYMENT AND REPLACING WITH A NEW ROOF COVERING SYSTEM.
- CONTRACTOR SHALL PROVIDE PRICE FOR BOTH OPTIONS BELOW AND SHALL INCLUDE ALL NECESSARY 2. CLOSURES, TRIMS, BACKUP FLASHINGS, SEALANTS, ETC. TO MAKE A WATER TIGHT ROOF SYSTEM.

24 GA METAL ROOF - U.V. RESISTANT WITH CONCEALED FASTENERS AR-38 STANDING SEAM BY AGWAY METALS OR EQUAL. MUST BE ABLE TO ATTACH S5 OR EQUAL STYLE MOUNTING CLIPS FOR RE-INSTALLATION OF SOLAR PANELS IN AREAS THAT HAVE EXISTING PANELS.

COLOR - RED (FINAL SHADE OF RED TO VARY BASED ON SUPPLIER AND COSTS).

BACKUP SYSTEM SHALL BE BLUESKIN/ICE GUARD AT ALL EAVES AND VALLEYS WITH MINIMUM 1.8m (6') OF EDGE OR VALLEY. BEYOND BLUESKIN/ICE GUARD THE BACKUP SYSTEM SHALL BE A SYNTHETIC UNDERLAYMENT WITH 150mm OVERLAP AT ALL JOINTS.

### OPTION 2

SHINGLES - ARCHITECTURAL STANDARD 30 YEAR SHINGLES

COLOR - BROWN OR BLACK SHINGLES, FASCIA AND TRIM METALS TO BE WHITE.

- 2. IF ADDITION ANCHORAGE AT SOLAR PANELS IS REQUIRED, CONTRACTOR SHALL MAKE THE NECESSARY ALLOWANCES TO INSTALL EXTRA CLIPS BELOW THE SOLAR PANELS.
- 3. WIND UPLIFT LOADINGS PER NRCC WIND LOAD CALCULATION FOR ROOF COVERINGS:


