## **NEIGHBOURHOOD ETIQUETTE:**

WELCOME NEW TENANTS INTO YOUR NEIGHBOURHOOD. TAKE TIME TO TALK TO YOUR NEIGHBOURS AND CREATE A GOOD RELATIONSHIP WHERE YOU FEEL COMFORTABLE DISCUSSING ISSUES AS THEY COME UP.

### **ENFORCEMENT:**

THE TOWN ENFORCES BY-LAWS TO ADDRESS EXCESSIVE NOISE, MINIMUM PROPERTY STANDARDS AND YARD MAINTENANCE TO ENSURE THE QUALITY OF YOUR NEIGHBOURHOOD.

YARD MAINTENANCE BY-LAW REQUIRES YARDS TO BE FREE OF:

- GRASS TALLER THAN 20CM (8 INCHES).
- EXCESSIVE GROWTH OF WEEDS.
- DEAD, DECAYING OR DAMAGED TREES.
- DEBRIS THAT POSE SAFETY RISKS.
- BROKEN GLASS.
- HOLES, PITS OR TRENCHES CREATING UNSAFE CONDITIONS.
- INOPERABLE OR DISMANTLED VEHICLES OR MACHINERY.
- DILAPIDATED OR ABANDONED STRUCTURES OR FENCES.
- ABANDONED OR DISCARDED APPLIANCES.
- POST-CONSTRUCTION OR POST-DEMOLITION MATERIAL.

THE RESPONSIBILITY TO ADDRESS PROPERTY AND MAINTENANCE COMPLAINTS WILL DIFFER DEPENDING ON THE TENANCY AGREEMENT.
